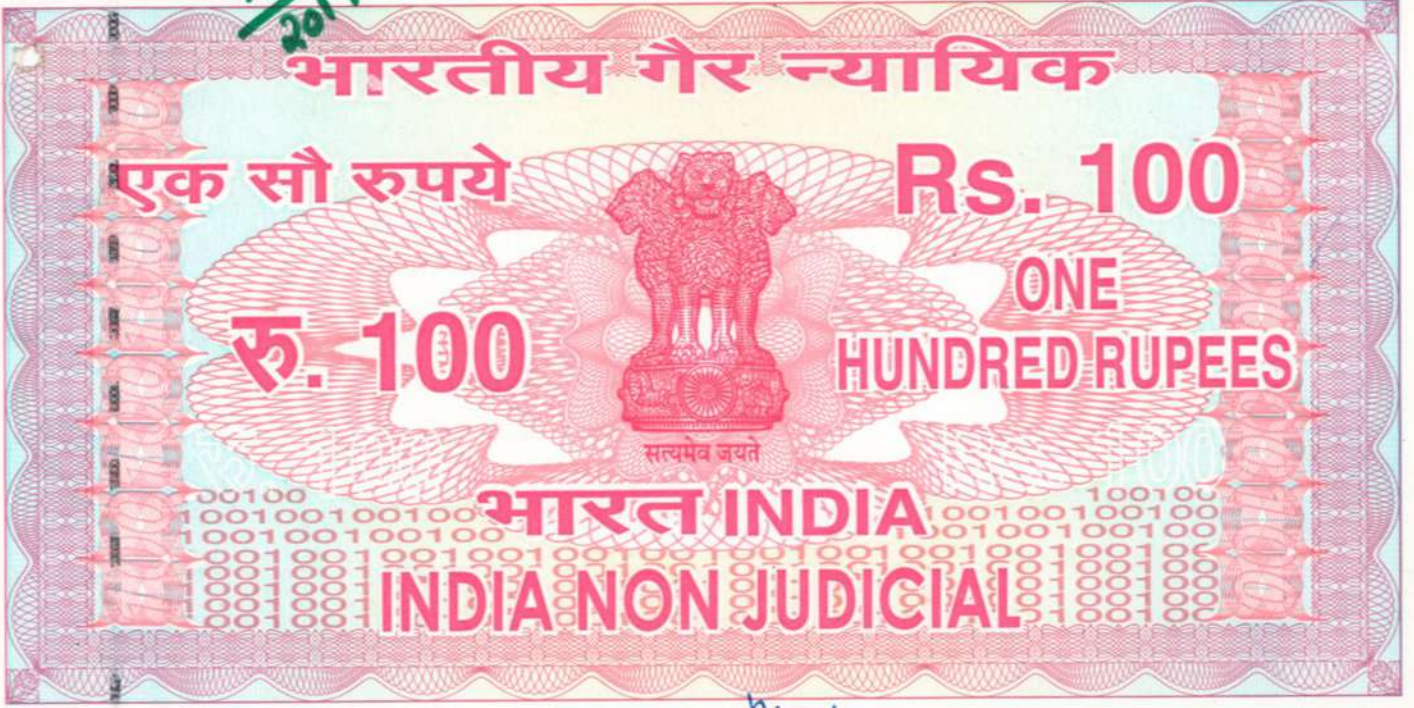

All the above authors are called individually "MEMBER OF THE BOARD OF TRUSTEES" which term, wherever the context permits shall mean and include any person holding the office of member of the Board of Trustees.

WHEREAS the Founders of Trust wishes that the work should be brought under a Trust so that the work will be perpetually sustained and maintained on a regular basis and it has now been decided to create a Trust named " R.N. ANDWHEREAS pursuant to the above, the Authors of the trust hereby declare a PUBLIC CHARITABLE TRUST by declaring the sum of Rs.1,000/- (Rupees One Thousand only) each totaling Rs.6,000/- (Rupees Six Thousand only) as the trust property and have decided to endow initial corpus fund and entrusted the same to the Board of Trustees (who at present are the authors themselves) to hold the same upon trust for the objects hereinafter specified and subject to the terms and conditions stipulated hereinafter:

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. CONSTITUTION :

The Authors do hereby constitute a PUBLIC CHARITABLE TRUST under the name hereinafter mentioned and appoint the Trustees. 4. OBJECTIVES :

4.1. The Principal objectives of the Trust shall be

4.1.1. To promote secular education of the needy and / or the Rural community in India and to seek government grant-in-aid wherever possible; to provide educational facilities and equipment's; to establish and maintain merit/means scholarship programs for students.

4.1.2. To establish and run educational institutions / training / professional institutions like schools, colleges, polytechnic and other types of educational, coaching and training institutions.

4.1.3. To establish and maintain a boarding house for the students who receive education in the Educational Institutions.

4.1.4. To promote programmers for the wholesome development of the neglected sections of the community with special training in and by imparting technical skills.

4.1.5. To establish and hostels, homes, crèches for the students belonging to rural areas and students in educational institutions in the neighborhood.

4.1.6. To establish Hospitals, Health Centers, Institutions related with medical & health and educating on different subjects including health, hygiene, nutrition, family planning etc.,

4.1.7. To undertake relief work, welfare programmes and social service among the rural poor, needy, tribal and hilly people.

4.1.8. To serve for the welfare and development of physically handicapped, mentally disordered, women and children, spastics, child laborer's, old age persons, widows etc.,

4.1.9. Organizing awareness camps, legal aid camps, environmental camps, work shops, medical camps etc., for educating the people.

4.1.10. For the uplift of the boys and girls and rural needy conducting vocational courses like computer training, carpentry, weaving, tailoring, electrical equipment's, training, Plumping etc.,

4.1.11. To undertake the projects for cultural and sports, human resources development, pollution control and environmental, production youth leadership, child labour, street children, slums etc.,

4.1.12. To undertake welfare programmes, income generating socio economic programmes, social service among grass root people.

It is made clear that none of the activities of the Trust will carry with the intent of earning profit. No activities of the Trust will be carried outside INDIA. The benefits of the Trust are open to all irrespective of caste, creed, religion, sex, etc.,

4.2. The objects incidental or ancillary to the above main objects are as follows:

4.2.1. To raise funds to support the aforementioned objectives.

4.2.2. To solicit, receive, hold and disburse funds to promote the objects stated above and to hold funds and investments in trust for the said objectives.

4.2.3. To open and operate Bank accounts of any description with any Nationalized/Scheduled bank or banks for the trust which shall be operated by Trustee of the First Part, S.RAJA and Trustee of the Second Part, N.SAKTHIVEL Jointly.

4.2.4. To appeal for and raise funds, subscription grants and loans as the Trustees may consider fit.

4.2.5. To take on lease or acquire property by purchase or otherwise to promote the objectives of the trust.

4.2.6. To enter into any contract or agreement or agreement or any other transaction for the purpose of promoting any of the objectives of the Trust.

4.2.7. To purchase, construct, take on lease, license, hire or otherwise acquire and sell and to hold, manage, administer and or otherwise deal with movable and immovable property, rights and privileges as the Board of Trustees may deem necessary, expedient or desirable for the promotion of any of the objectives of the Trust.

4.2.8. To sell, alienate, lease, give out on lease or license, mortgage, change, pledge, hypothecate transfer, surrender, dispose of and/or otherwise deal with all or any of the properties, funds and assets of the Trust as the Board may deem fit.

4.2.9. To appoint agents, representatives or other workers on such conditions as may be thought fit by the Board of Trustees.

4.2.10. To carry on such other activities as may be incidental to the promotions of any of the aforementioned objectives or of any other ancillary objectives related to the main objectives that may be considered fit by the Trustees.

5. MANAGEMENT :

5.1. All the trustees constitute the Board of trustees.

5.2. The trustee of the First Part, S. RAJA is the Chairman of the Trust and trustee of the Fourth Part, R.N. ARUL is the Secretary of the Trust. The tenure of Chairman and Secretary shall be for a period of three years and the trustees shall among themselves elect the chairman and secretary for the subsequent tenure of next three years and so on.

5.3. The Chairman of the Trust Board shall have all the powers of the management of the Trust and its properties in consultation with the other members of the Board of Trustees and shall have the power to delegate any of his powers for the purpose of day to day management of the Trust, to any one of the Trustees as he may deem fit.

5.4. If any of the trustees becomes bankrupt or found guilty by court of an offence involving moral turpitude or become insolvent or remains absent from India for a period of three years or resigns from his/her post or otherwise incapacitated physically, the chairman shall appoint his/her substitute.

5.5. For all practical purposes regarding the trust for Income Tax Department, Central and State Government Authority, a Trustee by name S. RAJA, Trustee of the First Part shall sign all documents for and on behalf of the Trust.

5.6. The Chairman shall preside over the meeting. In the absence of Chairman, those who are present at the meeting of the Board shall elect one among themselves to preside over the meeting. All decisions shall be taken by majority votes of those present and in the event of equality of votes the Chairman shall have a casting vote.

5.7. Subject to provisions herein, the Board of Trustees shall be entitled to exercise all such powers and do all such acts and things as are necessary to carry out the above mentioned objectives.

5.8. The Board of Trustees shall meet at least once in three months.

6. POWERS :

6.1. The Trustees shall pay, expend or utilize in India the Trust fund or such part there of as they shall in their discretion decide exclusively for all or any one or more of the aforementioned objectives.

6.2. The income and funds of the Trust will be solely utilized towards the objectives, and no portion of it will be utilized towards the objectives, and no portion of it will be utilized for payment to Trustees by way of profit, interest, dividends, etc., The trustees shall be reimbursed for their reasonable expenses incurred during the conduct of business related to the Trust.

6.3. It shall be lawful for the Board to frame rules and regulations for the conduct of management of the Trust.

6.4. The Board shall determine from time to time the amount it shall spend on the various aspects of the ministries of the Trust.

6.5. The Board shall have power to invest the corpus or the income from the Trust fund at their discretion in such investments strictly in accordance with the provisions of Section 13(1) (d) read with section 11(5) of the Income tax Act.

6.6. The Trustees shall have the power to acquire, manage, administer and to buy, sell and to dispose of in any manner any assets including movable and immovable nature upon the majority decision of the Board of Trustees.

6.7. The Trustees shall have power to borrow by mortgaging and / or by pledging the immovable and movable assets of the Trust by way of Term Loans (or) Over draft (or) Cash Credits from any Nationalized banks / Scheduled banks for the benefits of the Trust and remittance of such loan through the trust assets including movable and immovable property for more effectively carrying out the objects of the Trust and to execute necessary documents in the Trust name.

6.8. The trustees may invest the surplus fund in their hands in such securities, as they deem fit.

6.9.1. Establishment of separate committees for the different activities of the Trust.

6.9.2. Acquisition, Sale, Management and administration of trust properties.

6.9.3. Investment and application of trust funds.

6.9.4. Employment of staff members for the efficient and economical management of Trust and Educational Institutions etc., from time to time and their conditions of service including recruitment and imposition of punishment such as fine, suspension, removal and dismissal.

6.9.5. Setting apart such percentage of receipts every year as may be decided by the Board of Trustees for the proper upkeep and maintenance of the trust properties both movable and immovable.

6.10. The trustees shall in no case be liable for any loss to the trust estate unless the trustees are guilty of fraud.

7. ACCOUNTS AND AUDIT :

7.1. The Trust shall maintain regular books of accounts and the accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of accounts shall be placed before the Board for its approval within three months of the close of the Financial year.

7.2. The Financial year of the Trust shall be from 1st April to 31st March of each year unless otherwise decided by the Board.

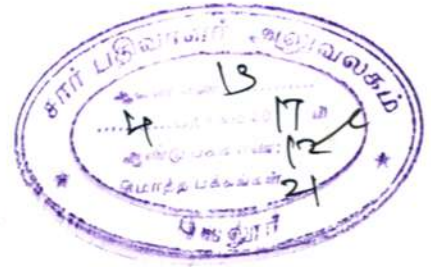

8. MEETING OF THE BOARD :

- 8.1. In addition to the Annual Meeting the Board shall meet at least once in three months.
- 8.2. The meeting shall be convened by the chairman of the Board of Trustees.
- 8.3. The Board shall transact any business that may be specified in the Agenda or otherwise agreed to by the Board of Trustees.
- 8.4. The Board shall also appoint an Auditor at the Annual meeting for the subsequent year.
- 8.5. Three-Fourth of the Trustees of the Board shall constitute the Quorum.
- 8.6. All decisions shall be carried out by the majority decision of the Board.
- 8.7. Any decision in writing signed by all the Trustees shall be binding on the Board as though it has been passed at a meeting of the Board of Trustees.
- 8.8. The meeting of the Board shall be convened after giving at least a week's notice. Unless those who are entitled to receive notice agree to accept a shorter notice.
- 8.9. The Board may invite others interested, in the work of the Trust to attend the meeting of the Board, but they shall not be entitled to attend all the meetings and not be entitled to vote in any meeting.

9. AMENDMENTS :

- 9.1. The formed principal objectives of the Trust shall be IRREVOCABLE.
- 9.2. The Board may amend the clauses relating to management of the Trust at a duly convened meeting of the Board by a resolution passed by a 3/4th majority.
- 9.3. Any amendment to the Trust deed will be carried-out only with the approval of the Commissioner (or) Director (Exemptions) of Income Tax in whose jurisdiction the trust is registered.

10. DISSOLUTION :

- 10.1. In the event of winding up of the Trust, the assets of the Trust shall be disbursed to other Trusts or Associations or Societies having similar objects and in no event they shall be appropriated either by the Trustees or any one related to the Trustees.
- 10.2. In case of failure of the trust for what it objectives or trust having become impossible to perform or to execute the objectives, the trustees shall move the court for applying the remaining trust fund for similar objects.
- 10.3. This is a Public registered Trust. The property of the trust shall in no case revert to the founder or his descendants or to any other person.
- 10.4. No part of the trust fund, either the corpus or the income there from, shall be utilized for any objectives other than that of the trust hereby created.
